For over 70 years AMOA has served as the voice of in-venue entertainment, representing over 1,300 operators, distributors, manufacturers and members of the broader industry. As the organization grew, our membership recognized the need to serve not just the industry, but our community as well. From 1978-1979 Wayne E. Hesch served as AMOA President. Both during and after his presidency, he was a strong advocate for expanding AMOA's educational offerings, resulting in a management program with his alma mater, Notre Dame University. When Hesch passed away in 1983 at the age of 43, AMOA honored his commitment to education by establishing a scholarship in his name. This would later become a catalyst and flagship program for Coin-Op Cares. Every spring since then, AMOA Members have sponsored promising students as they have applied to receive scholarships up to \$1,000. To date, AMOA has awarded over \$1.5 million to students from a variety of programs and schools across the country.
